

**AUTHORIZATION FOR MINOR'S  
PARTICIPATION IN SHOOTING SPORTS**

2. I have read and understand the provisions of California Penal Code §12101(a), which prohibits the possession of certain firearms by minors and is quoted on the reverse of this form. This statute authorizes participation in certain activities under the supervision of others with my permission.

3. I hereby consent to the minor's possession and use of firearms under the supervision of adults acting under the authority of the South Bay Rod & Gun Club. I understand that the scope of this possession and use of firearms may include, but is not necessarily limited to, sport shooting, instruction, and competitive shooting.

4. I have read and understand the South Bay Rod & Gun Club's Release, Waiver of Liability, and Indemnity Agreement, which is contained on the reverse of this Authorization. On behalf of the minor, I hereby agree to abide by the terms and conditions of that Release, Waiver of Liability, and Indemnity Agreement for claims, injuries or damages which may arise out of, or be related to, the minor's participation in shooting activities. The scope of this agreement includes not only the actual participation of the minor, but also to events which arise out of this participation, including transportation to shooting events or activities, whether or not the minor will be actually engaged in shooting.

5. This authorization may be cancelled by me in writing, delivered in person or via First Class Mail to South Bay Rod & Gun Club at its regular business address. Said cancellation, if mailed, will be effective five (5) business days after the date of post mark.

This form must be dated AND signed. The original of this form will remain in the records of South Bay Rod & Gun Club, and a copy kept (1) at the Main Range, and (2) in the immediate vicinity of any coordinator, instructor, or volunteer providing supervision to any minor engaged in activities under the auspices of the South Bay Rod & Gun Club.

Penal Code §12101

(a) (1) A minor shall not possess a pistol, revolver, or other firearm capable of being concealed upon the person.

(2) Paragraph (1) shall not apply if one of the following circumstances exists:

(A) **The minor is accompanied by his or her parent or legal guardian**, and the minor is actively engaged in, or is in direct transit to or from, a lawful, recreational sport, including, but not limited to, competitive shooting, or agricultural, ranching, or hunting activity, or a motion picture, television, or video production, or entertainment or theatrical event, the nature of which involves this use of a firearm.

(B) The minor is accompanied by a responsible adult, **the minor has the prior written consent of his or her parent or legal guardian**, and the minor is actively engaged in, or is in direct transit to or from, a lawful, recreational sport, including, but not limited to, competitive shooting, or agricultural, ranching, or hunting activity, or a motion picture, television, or video production, or entertainment or theatrical event, the nature of which involves the use of a firearm.

(C) The minor is at least 16 years of age, **the minor has the prior written consent of his or her parent or legal guardian** and the minor is actively engaged in, or is in direct transit to or from, a lawful recreational sport, including, but not limited to, competitive shooting, or agricultural, ranching, or hunting activity, or a motion picture, television, or video production, or entertainment or theatrical event, the nature of which involves the use of a firearm.

(D) **The minor has the prior written consent of his or her parent or legal guardian**, the minor is on lands owned or lawfully possessed by his or her parent or legal guardian, and the minor is actively engaged in, or is in direct transit to or from, a lawful, recreational sport, including, but not limited to, competitive shooting, or agricultural, ranching, or hunting activity, or a motion picture, television, or video production, or entertainment or theatrical event, the nature of which involves the use of a firearm.

## **RELEASE, WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT**

### **THIS CONTRACT LIMITS YOUR RIGHTS – READ IT**

IN CONSIDERATION of being permitted to enter the SOUTH BAY ROD & GUN CLUB for any purpose whatsoever the signator, hereinafter referred to as the undersigned, for himself/herself, any minor children for which the undersigned is exercising legal authority, and any personal representatives, heirs, and next of kin, hereby acknowledges, agrees and represents as follows:

1. **THE UNDERSIGNED HEREBY AGREES AND ACKNOWLEDGES** that participation in shooting sports can be a dangerous activity, including abrupt and explosive sounds, noxious fumes and gases, and high velocity projectiles designed to maim or injure. While the SOUTH BAY ROD & GUN CLUB takes reasonable steps to minimize risk of injury, there is no reasonable method to completely remove all risk of injury from active participation in shooting-related sports.

2. **THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE THE SOUTH BAY ROD & GUN CLUB**, its directors, officers, employees, volunteers and agents (hereinafter referred to as “releasees”) from all liability to the undersigned, his or her personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise, while the undersigned is in, upon, or about the premises or any facilities or equipment therein.

3. **THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS** the releasees and each of them from any loss, liability, damage or cost they may incur due to the presence of the undersigned in, upon or about the SOUTH BAY ROD & GUN CLUB premises or in any way observing or using any facilities or equipment of the SOUTH BAY ROD & GUN CLUB whether caused by the negligence of the undersigned, releasees or any other person or entity whatsoever.

THE UNDERSIGNED further expressly agrees that the foregoing RELEASE AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

By signing this document, **THE UNDERSIGNED ACKNOWLEDGES THAT HE/SHE HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND INDEMNITY AGREEMENT**, and further agrees that no oral representations, statements or inducement apart from the foregoing written agreement have been made.
