#### A Message from the SBRGC President

Here it is the new year and there is a whole bunch of Second Amendment items being challenged in the Court Systems all over the United States.

#### In San Diego Court

1. **Assault Weapon Law, Magazines over 10 rounds Ban, Ammunition Background Checks, and Billy Club issue.**
  - a) Status as of Dec 2022: Judge Benitez held court in December where he brought all the attorneys from four different cases into the court room at the same time. (Assault Weapons, Magazines over 10 Rounds, Ammunition Background Checks and Billy Club)
  - b) The attorneys were told there will be no more expert witness and they were tasked with gathering all the Firearms/Ammunition/Magazine & Billy Club laws put in to place between the Start of the 2<sup>nd</sup> Amendment up to 20 years past the 14<sup>th</sup> Amendment.
  - c) The attorneys are due to come back to court in the latter part of January 2023 and the case will be wrapped up in February 2023.

#### Out of town courts

1. **Youth Marketing Ban (LA Area):** The amendment was signed and the Junior Program is back up and running, however there is still major issues with this Youth Marketing Ban and the challenge continues in the court system.
2. **Handgun Roster (LA Area):** The California Rifle and Pistol Association (CRPA) filed a lawsuit in federal court against Attorney General Rob Bonta (D.) on August 1, 2022. The suit takes aim at the state's Unsafe Handgun Act (UHA), alleging that the law's requirements for a handgun to be deemed "safe" for sale in the state represent an unconstitutional violation of the Second Amendment. The Judge hearing the case has already ruled on similar cases in our favor, February is when the court resumes.
3. **New York Concealed Weapons Law:** This was passed right after the Supreme Court ruled in the Bruin Case and now a NY Judge has declared it as unconstitutional and a gun group obtained an emergency stay and it has made it up the Supreme Court. Sounds like good news!

The next General Membership Meeting is scheduled for **January 24<sup>th</sup>** starting at 6:00pm. We will be conducting a table top sale and we will go over the accomplishments of the club in the past 12 months. During the January meeting we would normally be counting ballots, but with only three people running for three positions with no opposition there is no vote needed. Congratulations and thank you to the winners!

Some of the scheduled **RANGE** work includes:

- Modify the Disk (welding)
- Modify Gate (welding preps for new install)
- Replace the tarp & bungees on the cover to R6
- Level the 40' container on R5
- Clean two drain covers (latest rain has covered them up)
- Clean the culvert at the main entrance
- Dig two holes in the maintenance yard for gate posts (Power Auger)
- Set two gate posts in concrete
- Fence old gate hole with barbed wire
- Clear weeds from "U" Turn Sign R6
- Connect airline to hose reel in maintenance yard Replace mic wire on R2
- Fix target line R6 (50 Yd)
- Repair water line to quonset hut
- Remove weeds from number boards and target lines R6

Some of the scheduled **RANCH** work:

- Dig Six holes for Caretakers back yards (Corners)
- Wire up lights/outlets in container
- Pull wires to build 1 from power pole
- Form and pour concrete curbs for power/data pull boxes
