#### **A Message from the SBRGC President**

South Bay Rod & Gun Club is still working to keep up with rapidly changing regulations and orders regarding the Coronavirus (COVID-19). It is our intent to keep our members and the public safe. Wearing of Masks is mandatory when you are within 6' of another individual. When you are shooting at your assigned spot you can relax your wear of the mask if you so choose, but once you depart your shooting spot you need to have the mask on. This allows others to move more freely behind the red firing line. RSO's will be enforcing this rule as it is intended to keep everybody safe from spreading the virus from one individual to another individual.

The political environment is currently upon us as seen by the volumes of mail and the TV Political ads.

There is one that will have a major impact on South Bay Rod & Gun Club. The club is a Corporation and has been for a number of years. The Club currently owns over 600 acres of property which is currently under control of Prop 13. (Taxes can only increase by 2% a year)

**Prop 15** if approved will cause the property taxes that the club pays to increase to current market value and will be adjusted yearly. This will be a major financial impact on the clubs finances each year. We need to keep the taxes down so I recommend a NO vote on Prop 15

Range/Ranch Development is currently working or tracking the following main projects:

- ⇒ Range Water System. Water well permit modifications has been submitted to the county and we are currently gathering additional information for the county. If approved we will be working on the water system by installing a filter system at each sink.
- ⇒ Range Complex Hazmat Assessment is being conducted to determine if an item is standard waste or hazmat waste.

You are all invited to attend the WORK PARTY on Nov 7, 2020 and then enjoy some shooting in the afternoon. The work will be at both the Range and Ranch.   - ◇ We will be setting up the maintenance yard as we start to close down the Quonset Hut work zone.
- ◆ Shooting Table Refurbishment by Quonset Hut
- ◆ Number board refurbishment by Quonset Hut Electrical
  - ◇ Phone Ringer Replacement – Range 2
  - ◇ Light repair by main gate
- ◆ Drain Pipe Repair by the Water Tank
  - ◇ Some small concrete work around the drain entrance for ease of water flow
  - ◇ Pipe Replacement around the drain pipe discharge
- ◆ Water Pipe Repair by Water Tank for the lower pad
- ◆ Start preps for Club House Wall Repair

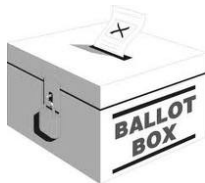
